

## **National Music Centre Spring Fundraising Campaign Prize Draw Terms and Conditions**

1. Entrants into the Prize Draws shall be deemed to have accepted the following Terms and Conditions:

### **Who Can Enter, For What and How Winners Are Chosen**

2. The "Geddy Lee Prize Draw" is open to National Music Centre (NMC) entrants who provide their name, address, phone number and email address to NMC, and are aged 18 or over. No donation necessary for entry. There is no entry fee associated with Prize Draws.
3. NMC Employees, Board Members, and Sponsors, their immediate family members and those with whom they are domiciled are not eligible to enter or win NMC Prize Draws.

### **How Winners Are Communicated With and How to Confirm Acceptance of Prize**

11. The prize winners will be notified via phone call and email.
